- Pension statement or pension adjustment notification from your statutory pension insurance, e.g. for an old-age, widow's, orphan's or a disability pension
- Benefit verification for further pensions,
 e.g. supplementary pension fund (ZVK), regional state pension fund (VBL), retirement annuities, foreign pensions
- Proof of wage replacement benefits,

e.g. unemployment benefit, maternity benefit, insolvency payments, sickness benefit, unemployment benefit (ALG II) (Hartz IV scheme), parental benefit

- 🔲 Foreign income
- Income from capital gains, e.g. sale of properties, trade in crypto currencies
